

## **Dana Launches \$425 Million Senior Notes Offering**

MAUMEE, Ohio, Dec. 4, 2014 /PRNewswire/ -- Dana Holding Corporation (NYSE: DAN) ("Dana") today announced that it is commencing, subject to market conditions, a registered offering of \$425 million aggregate principal amount of senior unsecured notes due 2024. The company intends to use the proceeds from the offering to purchase up to \$360 million aggregate principal amount of its 6.500% Notes due 2019 (the "2019 Notes") in the company's previously announced tender offer, to redeem \$40 million aggregate principal amount of the 2019 Notes, to pay related fees and expenses and for general corporate purposes which may include repayment of indebtedness.

Citigroup Global Markets Inc.; BofA Merrill Lynch; Barclays Capital Inc.; Deutsche Bank Securities Inc.; J.P. Morgan Securities LLC; UBS Securities LLC; and Wells Fargo Securities, LLC are acting as joint-bookrunning managers in the offering.

The offering is being made pursuant to the company's automatic shelf registration statement on Form S-3 filed with the Securities and Exchange Commission (the "SEC") on December 3, 2014, and pursuant to a preliminary prospectus supplement, which will also be filed with the SEC.
