Restricted stock units for Reporting Person will be cash settled.
- Restricted stock units previously granted pursuant to the Dana Holding Corporation 2012 Omnibus Incentive Plan.
- Restricted stock units granted cliff vest three (3) years from date of grant.
- Each restricted stock unit granted represents the right to receive cash for each share equal to the market value per share.
- Stock appreciation rights previously granted pursuant to the Dana Holding Corporation 2012 Omnibus Incentive Plan.
- Stock appreciation rights granted vest in three (3) equal annual installments beginning on the first year anniversary date of the grant. Stock appreciation rights are cash-settled only.
