Until fully vested, the award will continue to vest on a pro-rata basis for each quarter the reporting person performs services for Dana as an active employee. In the event reporting person retires or discontinues employment for any reason prior to 12/31/11, the award will be released at the time of reporting person's retirement and/or termination date.
