- Stock options granted pursuant to the Dana Holding Corporation 2008 Omnibus Incentive Plan.
- Stock options granted vest in three (3) equal installments beginning on the first year anniversary date of the grant. Post retirement, options may be exercised for a period equal to the shorter of five years from retirement or the remaining option term.
