Vested shares will be delivered to the reporting person on a deferred basis following the date on which the reporting person terminates employment with Dana.
- 5. Dividend equivalents credited with respect to previously granted restricted stock units become vested proportionately with the restricted stock units to which they relate, which restricted stock units vest in three equal annual installments beginning March 1, 2005. Vested shares will be delivered to the reporting person on each annual anniversary date.
